

# FEI JUMPING EUROPEAN CHAMPIONSHIPS 2020 FOR YOUNG RIDERS AND JUNIORS

**Vilamoura (POR) 19-26 July 2020**

Eligibility Criteria

Published on 17 December 2019 (V1)

**Timeline for Athletes and Horses to achieve the FEI minimum eligibility criteria is from 1 January 2019 through to 21 June 2020, Certificates of Capability to be submitted to the FEI by 22 June 2020.**

A) Athletes and Horses that participated in the 2019 FEI Jumping European Championship for Young Riders and Juniors in their respective age category are qualified to compete.

### Young Riders

B) Athletes and Horses that have completed the first round of a Grand Prix Competition at a CS11\* to CS15\* outdoor Event, or the first round of the main Competition at a CS11\* to CS15\* outdoor Event if it is not the Grand Prix, with a Score of not more than eight Penalties are qualified to compete, providing the height of obstacles in the initial round of the Grand Prix or the main Competition is at least 1.40 m.

C) Athletes and Horses that have completed the first round of a Nations Cup or Grand Prix Competition at a CSIO1\* to CSIO5\* outdoor Event with a Score of not more than eight Penalties are qualified to compete, providing the height of obstacles in the initial round is at least 1.40 m.

### Juniors

D) **Athletes and Horses** that have completed the first round of a Grand Prix Competition at a CS11\* to CS15\* outdoor Event, or the first round of the main Competition at a CS11\* to CS15\* outdoor Event if it is not the Grand Prix, with a Score of not more than eight Penalties are qualified to compete, providing the height of obstacles in the initial round of the Grand Prix or the main Competition is at least 1.30 m.

E) **Athletes** that have completed the first round of a Nations Cup or Grand Prix Competition at a CSIO1\* to CSIO5\* outdoor Event with a Score of not more than eight Penalties are qualified to compete, providing the height of obstacles in the initial round is at least 1.30 m.

**Horses** that have completed the first round of a Nations Cup or Grand Prix Competition at a CSIO1\* to CSIO5\* outdoor Event in 2019 with a Score of not more than eight Penalties are qualified to compete. A Horse that has taken part in a Nations Cup or Grand Prix Competition at a CSIO1\* to CSIO5\* outdoor Event in the year of the Championship is not eligible to take part in the Junior Championship.

**NB:** Athletes may participate in the Grand Prix at CS11\* Events from the year in which they reach their 14<sup>th</sup> birthday and in the Grand Prix at CS12\* Events from the year in which they reach their 16<sup>th</sup> birthday. Athletes may participate in the Grand Prix at CS13\*/4\*/5\* Events and in the Nations Cup and Grand Prix of CSIO1\* to CSIO5\* Events from the year in which they reach their 18<sup>th</sup> birthday.

**Juniors and Young Riders**

F) Athletes and Horses that have completed the first round of a Grand Prix Competition in their own Category at a CSIJ/CSIJ outdoor Event, or that have completed the first round of a Grand Prix Competition at a CSIU25 outdoor Event, or the first round of the main U25 Competition at a CSIU25 outdoor Event if it is not the Grand Prix, with a Score of not more than eight Penalties are qualified to compete.

**NB:** Athletes may participate in CSIU25 Competitions from the year in which they reach their 16<sup>th</sup> birthday; Athletes may participate in CSIU25 Competitions from the year in which they reach their 14<sup>th</sup> birthday until the end of year in which they reach their 15<sup>th</sup> birthday if the height of obstacles in the initial round does not exceed 1.40 m.

G) Athletes and Horses that have completed the first or second round of a Nations Cup Competition in their own Category at a CSIOY/CSIOJ outdoor Event with a Score of not more than eight Penalties, or that have completed the first round of the Grand Prix Competition in their own Category, or the first round of the main Competition in their own category if it is not the Grand Prix, with a Score of not more than eight Penalties, are qualified to compete.

H) *In addition, the following Competitions at the CSI3\* Vilamoura (POR) will act as a qualifier for Junior Athletes who complete the first round of the Competition with a Score of not more than eight Penalties.*

- a. *Competition No: A-26 – 12.10.2019*
- b. *Competition No: A-60 – 27.10.2019*
- c. *Competition No: A-91 – 10.11.2019*

I) *In addition, the following Competitions at the CSI3\* Vilamoura (POR) will act as a qualifier for Junior Athletes who complete the first round of the Competition with a Score of not more than eight Penalties.*

- a. *Competition No: A-29 – 09.02.2020*
- b. *Competition No: A-44 – 16.02.2020*
- c. *Competition No: A-59 – 23.02.2020*
- d. *Competition No: A-74 – 01.03.2020*
- e. *Competition No: A-89 – 08.03.2020*
