### Jumping

**Timeline for Athletes and Horses to achieve the FEI minimum eligibility criteria is from 1<sup>st</sup> January 2014 through to 12<sup>th</sup> July 2015, Certificates of Capability to be submitted to the FEI by 13<sup>th</sup> July 2015.**

- A) Athletes and/or Horses that participated in the 2014 FEI European Championship for Young Riders and Juniors in their respective age category are qualified to compete.
- B) Athletes (of the appropriate age) and/or Horses that have completed the first round of a Grand Prix competition at any 2014 or 2015 CSI1\*/CSI2\* outdoor Event or CSIO1\*/CSIO2\* outdoor Event with a score of not more than eight penalties are qualified to compete.
- C) Athletes (of the appropriate age) and/or Horses that have completed the first round of a Grand Prix competition at any 2014 or 2015 CSI3\*, CSI4\* or CSI5\* outdoor Event or the first round of a Nations Cup or Grand Prix competition at any CSIO3\*, CSIO4\* or CSIO5\* Event with a score of not more than eight penalties are qualified to compete.
- D) Athletes and/or Horses that have completed the first round of a Grand Prix competition in their own Category at a 2014 or 2015 European CSIJ/CSIJ outdoor Event with a score of not more than eight penalties are qualified to compete.
- E) Athletes and/or Horses that have completed the first or second round of a Nations Cup competition in their own category at any 2014 or 2015 European CSIOY/CSIOJ outdoor event with a score of not more than eight penalties, or that have completed the first round of the Grand Prix competition in their own category with a score of not more than eight penalties, are qualified to compete.
- F) In addition, the following competitions at the CSI3\* Vejer de la Frontera – Sunshine Tour (ESP) will act as a qualifier for Junior Athletes who complete the first round of the competition with no more than eight penalties.
  - a. Competition No: 31 – 22.02.2015
  - b. Competition No: 67 – 01.03.2015
  - c. Competition No: 103 – 08.03.2015
  - d. Competition No: 139 – 16.03.2015
  - e. Competition No: 177 – 23.03.2015
- G) In addition, the following competitions at the CSI3\* Arezzo – Toscana Tour (ITA) will act as a qualifier for both Junior Athletes and Young Riders who complete the first round of the competition with no more than eight penalties.
  - a. Competition No: 22 – 20.03.2015
  - b. Competition No: 38 – 21.03.2015
  - c. Competition No: 85 – 27.03.2015
  - d. Competition No: 101 – 28.03.2015
  - e. Competition No: 150 – 03.04.2015
  - f. Competition No: 165 – 04.04.2015

H) In addition, Competition No: 8 at the CSI2\* Chepstow (GBR) on 03.05.2015 will act as a qualifier for Junior Athletes who complete the first round of the competition with no more than eight penalties.
